**MEMBERSHIP INFORMATION - PERTINENT BY-LAWS 2022**

1. SENIOR MEMBERS shall be boat owners whose applications have been accepted by the Membership Committee and whose dues are not in arrears. In this context, a boat owner is defined as a person who pays an annual fee for mooring, docking or dry sailing.
2. ASSOCIATE MEMBERS shall be members who are not boat owners in the sense of the preceding section, whose applications have been accepted by the Membership Committee and whose dues are not in arrears. Beaconsfield Residents receive a 15% discount.
3. NON-RESIDENT MEMBERS shall be members whose residence and regular place of employment is outside a radius of 100 kilometers from the Clubhouse in Beaconsfield and who do not regularly use the facilities of the Club and shall have paid their full entrance fee.
4. SENIOR, ASSOCIATE, INTERMEDIATE members' spouses and their children (under the age of 21 and living at home) shall enjoy Club privileges.
5. JUNIOR MEMBERSHIP – INDIVIDUAL – PRIVILEGES do not extend to siblings or parents/guardians.
6. New membership priority will be given to residents of Beaconsfield until the end of February.
7. Voting rights shall be restricted to SENIOR MEMBERS.
8. Alongside Docking is only available to members who have paid Senior Entrance Fees.

**ENTRANCE FEES 2021**

**SENIOR:** (HARBOUR) - \$895.00 in one payment or by installments of \$480.00 (1<sup>st</sup> year) + \$220.00 (2<sup>nd</sup> year) + \$220.00 (3<sup>rd</sup> year) + \$220.00(4<sup>th</sup> year). Total: \$1,140.00 (Senior members using only dry sail and mooring are exempted from paying entrance fees.)

**ASSOCIATE:** ASSOCIATE members pay NO ENTRANCE FEES. Entrance fees are only payable if a request for SENIOR STATUS (boat owning) is made. Entrance fees of the year of joining as a SENIOR MEMBER are reduced by 20% per year of ASSOCIATE MEMBERSHIP. After 5 consecutive years as an ASSOCIATE MEMBER, no entrance fees are payable. Associate members who are residents of Beaconsfield will receive a 15% reduction on associate membership fees.

**INTERMEDIATE:** INTERMEDIATES pay NO ENTRANCE FEES. At age 30 they may become an ASSOCIATE MEMBER or a SENIOR MEMBER (boat owning). In the case of becoming a SENIOR MEMBER, ENTRANCE FEES of the year of joining are reduced by 10% per year of consecutive years as an INTERMEDIATE MEMBER (age 19 to 29 years).

**JUNIOR:** No Entrance Fees (age 12 to 18 years).

4. I acknowledge that the Club has no responsibility, nor do they assume any responsibility for accidents, thefts, loss or damage of any nature, either on land or water.
5. I further agree to maintain proper Liability Insurance on my vessel while docked, moored, stored or utilizing Club property, and to maintain identification on the hull either by name or number or as requested by the Harbour Master.
